Yes – additional funding from other sources, including Salvation Army Emergency Welfare Reserve funds (available first time this year), the MACP (Margaret A. Cargill Philanthropies) grant, and an Ameren grant of \$5,000. Also, the Army refers people to the Vermilion Advantage Job Board, and posts job information and flyers in the food pantry room. Case manager will help someone search for a job if they are looking for a specific position. Salvation Army and Goodwill Industries (Danville) presented employment skills workshops over the summer months (June, July, August), focusing on interview skills training, resume writing and job search.
